3. Complimentary Airline registration applies to any employee that is involved in purchasing, analyzing, reviewing, installing or receiving aircraft parts for an air carrier holding FAA certificate under Part 121, 135, or 129 (comparable authority applies to non-US air carriers). All complimentary airline attendees must be MARPA members; complimentary membership is applied as carriers register for the event.
4. Complimentary Government registration applies to any government employee that is involved in purchasing, analyzing, reviewing, installing or receiving aircraft parts, or that sets or enforces policy related to PMA parts (including employees of non-US governments).
